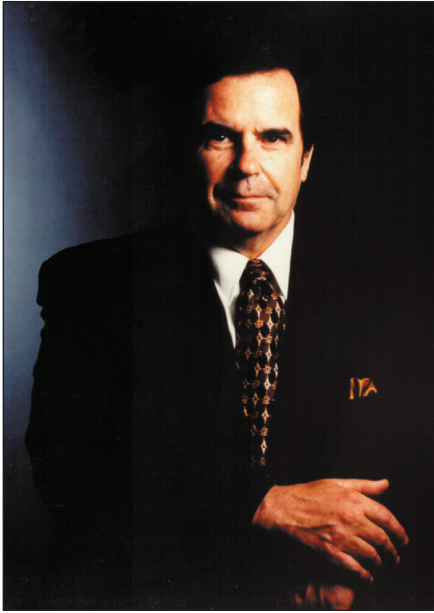


George F. Martin
